

# WAUKEGAN TOWNSHIP ROAD & BRIDGE PUBLIC HEARING FEBRUARY 26, 2015

The Town Public Hearing for “Road & Bridge and Appropriations for the fiscal year beginning March 01, 2015 and ending February 28, 2016 of Waukegan Township, County of Lake, of the State of Illinois was held at Waukegan Township’s Supervisor’s Office located at 149 South Genesee Street, Waukegan, Illinois on Thursday, February 26, 2015.

The meeting was called to order at 5:25 p.m., by Waukegan Township Supervisor Patricia Jones.
